# WEST LEBANON TOWNSHIP January 3, 2023

The regular meeting of the West Lebanon Township Board of Commissioners was called to order at 7:00 p.m. by President Harry Fox with the Pledge of Allegiance

Michelle Testerman made a motion, seconded by Phylis Dryden, and agreed by the Board to correct the minutes written on December 5, 2022, with the needed corrections of replacing Mr. Steckbeck with Bennett Holdings and changing with to without in the visitor's discussion.

## **VISITORS' ADDRESS:** There were 8 visitors in attendance.

Jon Litz requested to address the Board regarding the noise pollution of people driving through the Township. He stated that the loud noises as well as the loud exhausts of vehicles passing through the Township is an invasion into his personal space. He is requesting to know if we have any recourse to address this issue.

Harry Fox stated that we are able to call the police.

Jon Litz stated that this is invading his home, and what can be done if the police are not near his home, what can be done to mitigate this?

Paul Bametzreider stated that he can look into the provisions of the current ordinance to review, however the problem is how to enforce a noise ordinance. It is also something that the police may not be set up to monitor.

Jon Litz stated that there is an ordinance.

John Brenner – Correct

Jon Litz stated that this should be the same as a noise ordinance or disturbing the peace. This is not only traveling through the Township but residences as well.

Paul stated that if someone can be identified, a call needs to be made to the Police or Township to report it with the names, location, times and issue.

Jon Litz stated that it is a violation of his personal space and that it is getting worse, and the township should be looking into having the Police Department spend more time in the Township to enforce this issue. He stated that he also has an issue with one of his neighbors parking in the yellow curb area on 23<sup>rd</sup> stated. This is ongoing and he has already reported it to the Township. He handed out pictures of the issue to each of the Board members.

John Brenner stated that a notice was already sent to this individual when it was reported last week.

Discussion was held on the best ways to deal with the noise and included having the Police Department spend more time in the Township. Chief Knight stated that he will pass the information onto the officers.

Solicitor Paul C. Bametzreider stated that the Courts have issued an order that Raponi needs to remediate the area before June 30, 2023, or he will be found in contempt of court. Josh Weaber will be doing the inspection. North Lebanon Township will be going after Mr. Raponi for lack of permits.

Michelle asked to know who is paying for this inspection.

Josh Weaber stated that he was going to request that the Township reimburses him as there has been no Raponi cost to date. He stated that he can get the exact total, but the amount is approximately \$5,000.00. He is requesting to know if he can put together information and have the Township pay \$1,000.00 for the inspection.

John Brenner stated that it should be in the court order who is responsible to pay for it. Paul stated that he will have to review the order to confirm. He stated that he had tried to get counsel to agree, and it is not the Township's job to collect fees for Weaber. John asked about the Township fees.

Paul said he would look into the order to see what it says about costs.

He also stated that the Bennett Holdings issues have been resolved.

At this time, Solicitor Paul C. Bametzreider left the meeting.

**Treasurer's report:** Copies of the report were given to the Board members and available to the visitors in attendance.

John Brenner made a motion, seconded by Michelle Testerman and agreed by the Board to accept the Treasurer's report.
