The regular meeting of the West Lebanon Township Board of Commissioners was called to order at 7:00 p.m. by Vice President Michelle Testerman with the Pledge of Allegiance

Justin Snyder made a motion, seconded by Michelle Testerman, and agreed by the Board to approve the minutes for December 4, 2023, with the correction of August being changed to November under the police report. All in favor.

VISITORS' ADDRESS: There were 11 visitors in attendance.

Jeanette Drahovsky, 2120 Church Street, wanted to thank John Brenner for taking care of the generator outside the township and getting Met-Ed to fix it. That way she does not have to hear it running 24/7. She hasn't heard it run since that Friday. Jeanette stated she appreciates John Brenner's efforts.

Treasurer's report:

Lebanon County Treasurer Real Estate Taxes collected are \$1,027.91 from 11/26/23 to 12/9/23 Municipal (\$955.91), Street Light Taxes (\$72.00).

Lebanon County Treasurer Real Estate Taxes collected are \$597.97 from 12/10/23 to 12/23/23 Municipal (\$539.06), Street Light Taxes (\$58.91).

POLICE: Chief Knight was in attendance and gave the report for the month of December 2023

Chief Knight stated the police department has 2 new cadets who graduated and passed their test and are currently in the FTO program, which is 16 weeks long. Chief Knight stated Officer Hilbert and Detective Sargent Bahmey did a good job towards a wanted suspect who was a suspected shooter in Florida. The suspect was suspected to shoot 2 people in Lebanon, and he was caught in West Lebanon. The police department had a meeting for the regional police

department merger and currently does not have more information. There is a committee meeting scheduled for January 25, 2024, at 3:00 pm at North Cornwall Township.

Phylis Dryden asked if the police department was still getting cooperation from New Jersey about the murder case.

Chief Knight stated yes and still waiting on somethings for that case.

John Gurganus stated he apologizes to him and the family of the deceased for someone bringing that up during a public meeting and it should have been done one on one.

SPEEDWELL FIRE COMPANY:

Chase Testerman gave the following report for the year 2023 as follows:

62 calls for the year with 159 personnel for 73 hours and 45 minutes.

Fire Police responded to 17 calls for the year.

Training for hours for the year: 129 personnel for 309 hours and 30 minutes.

Public Service Events: 65 personnel for the year for 193 hours and 30 minutes. Public Service Events include events like parades, Breakfast with Santa.

Chase Testerman gave the following report for December 2023 as follows: 5 calls for the month with 12 personnel.

HIGHWAY: Phylis Dryden stated residents will have to be patient with salting and snow plowing on the roads due to new employees running the equipment.

WATER: Michelle Testerman stated the daily average for the month was 33,774 gallons per day (GPD). The water tank is ½ full. The total City of Lebanon Authority (COLA) water was zero (0).

SEWER: Michelle Testerman stated nothing to report.

Joe Templin asked if the sewer has been flushed or checked.

John Brenner stated yes certain sections are jetted yearly. John asked checked for what. Joe stated if they are all flowing.

John Brenner stated yes that is done yearly. Different sections are flushed and jetted yearly. Joe stated that when the system was first put in, there was a blockage.

TOWNSHIP BUILDINGS: Joe Templin stated nothing to report.

RECREATION: Joe Templin stated nothing to report.
